Landfill Manager's Report

- **Liquid waste:** Cargill has temporarily shut down liquid waste generation. As a result, the landfill is not accepting fly ash until operations resume. Joe met with Cargill representatives in December to discuss the situation.
- **Budget**- Joe is preparing the new budget for presentation to the Finance Committee. Tim Beulow of SCS is scheduled to present the updated financial model at the February meeting.
- **EMS Internal Audit**- The audit will be conducted via Zoom in coordination with Marshall County.
- **EMS External Audit**- scheduled in March 2026 and will be conducted by Region XII Council of Governments (COG) auditors, the DNR EMS Representative, and the DNR FABA Section Supervisor.
